

## **“CO-OP DEALER WEBSITE iPhone Xs GIVEAWAY” CONTEST OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

- 1. To Enter.** Beginning 12:00.00 p.m. EST on January 1, 2020 through 11:59.59 p.m. EST on February 28, 2020 (the "Contest Period"), log on to <https://www.insul8.ca> (the "Site") to enter the “CO-OP DEALER WEBSITE iPhone Xs GIVEAWAY” Contest (the “Contest”). The potential winner will be contacted by a representative of Owens Corning Canada LP (“Sponsor”) via the email address provided on the entry form and is subject to verification. The potential winner will be required to correctly answer a time-limited skill testing question in order to be eligible to receive the prize. If the question is answered incorrectly, the prize will be forfeited. No other methods of entry will be accepted.
- 2. Limit:** Each entrant may enter one (1) time only during the Contest Period. All electronic entries must be received by 11:59:59 p.m. EST on February 28, 2020. Use of multiple email accounts will disqualify an entrant. Sponsor is not responsible for technical, hardware or software malfunctions, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, lost, late, misdirected, illegible, mutilated, garbled or delayed entries or other communications or other technical problems related to online entries. The use of scripts, programs or an automated system to enter is strictly prohibited. Sponsor, in its sole discretion, reserves the right to disqualify any person who tampers with the entry process or the operation of the Site, or who otherwise violates these rules. By entering, entrants accept and agree to abide by the terms of these Official Rules.
- 3. Eligibility.** This Contest is only open to permanent lawful residents of Canada, who have reached the age of majority in their province at the time of entry. Employees of the Sponsor and their respective affiliates, subsidiaries, parents, representatives, advertising, promotion and publicity agencies (“Sponsor, and their agents”) and the immediate family members and persons living in the same household of each are not eligible. Entrants must be employed by an Owens Corning customer’s retail establishment.
- 4. Prizes.** There is one (1) Grand Prize available to be won. Odds of winning the prize depend on the number of eligible entries received. Grand Prize is not transferable.

The one (1) Grand Prize is an iPhone Xs, silver, 64GB (approx. retail value \$1179). Prize is not transferable. No substitution of prize for cash or other goods or services is permitted, except Sponsor reserves the right to provide a substitute prize of approximately equal or greater value, if the advertised prize becomes unavailable.

- 5. Winner Selection and Notification.** Potential Prize winner will be selected by a random draw that will be made by the Sponsor on or around 11:00 am EST on March 4, 2020. The selected potential winner will be contacted by a representative of the Sponsor using the email address provided on the entry form. The potential winner will also be required to correctly answer a time-limited skill-testing question to be eligible to receive the prize. If the question is answered incorrectly, the prize will be forfeited. If a selected potential winner cannot be contacted using the email supplied with the entry or is contacted and does not respond via email as directed within 5 days of attempted notification or refuses the prize or is ineligible to accept the prize, the prize will be forfeited and may be awarded to an alternate potential winner.
